

- Travel into Purdy, turn west at the light onto Hwy 302 W.
- Cross the Wauna Bridge, travel 5.1 miles
- Turn RIGHT onto Hwy 302 W, Elgin Clifton Rd KPN, toward Shelton/Allyn
- Travel 1.2 miles, turn RIGHT onto 150th
- Travel 0.1 miles (end of chain link fence) turn LEFT onto 1st road, Rocky Creek Conservation Area.
- Follow road approximately 0.8 mile through park, through PackLeader's green farm gate.
