Disaster & Emergency Plan for PackLeader Farm Herding Events

FIRE: Dial 911. All dogs should be crated or leashed securely. Owners/handlers must make sure that they, their dogs and vehicles are out of driveways that Fire and Emergency vehicles would use for approach to the site of the fire.

THUNDERSTORMS WITH LIGHTENING: Should lightening be observed, all people and dogs should be in the security of their vehicles or in the shelter of any barns or buildings until the storm has passed.

INJURY TO A DOG: Alert the veterinarians on call – All Creatures Animal Hospital, 4241 State Hwy 3 W, Bremerton, WA 98312. Phone: 360-377-3801. Driving directions from PackLeader Farm: Return to 150th Ave and turn left onto Elgin Clifton Rd KPN/WA 302 for approx. 1.2 miles. Turn left onto WA 302 KPN/Gig Harbor-Long Branch Hwy for 5.3 miles. Turn left onto Purdy Dr NW/WA 302 for 1.0 miles and then merge onto WA 16 toward Bremerton for 11.3 miles. WA-16 becomes WA-3N and go 1.0 miles to 4091 State Hwy 3W, Bremerton, WA 98312.

INJURY OR HEALTH PROBLEM WITH A PERSON: The emergency response team for the area will be called immediately. Dial 911. A first-aid kit is on the premises. Nearby hospitals/emergency rooms are:

St Anthony Hospital, 11597 Canterwood Blvd NW, Gig Harbor, WA (appx. 9.1 miles) Phone: 253-530-2000. Exit PackLeader Farm, go back through the conservation area turn right onto 150th Ave KP N. Drive for 0.1 miles. Turn left onto WA-302 KP. Drive for 1.2 miles. Turn left to stay on WA-302 KP. Drive for 1 mile. WA-302 KP becomes WA-302. Drive for 4.1 miles. Turn RIGHT onto Purdy Drive NW. Drive for 0.8 miles. Take WA-16 E on your right. Drive for 0.7 miles. Take exit on your right towards Burnham Dr NW. Drive for 0.3 miles. Take the roundabout and exit at the third street onto Burnham Drive NW. Drive for 0.2 miles. Take the roundabout and continue on Canterwood Blvd NW. Drive for 0.5 miles. You have reached the hospital.

Multicare Allenmore Hospital, 1801 S Union Ave, Tacoma, WA. (appx. 20.6 miles). Phone 253-459-6633. Exit PackLeader Farm, go back through the conservation area turn right onto 150th Ave KP N. Drive for 0.1 miles. Turn left onto WA-302 KP. Drive for 1.2 miles. Turn left to stay on WA-302 KP. Drive for 1 mile. WA-302 KP becomes WA-302. Drive for 4.1 miles. Turn RIGHT onto Purdy Drive NW. Drive for 0.8 miles. Then merge onto WA-16E for 12.2 miles. Take the Union Ave Exit, turn left onto So Union Ave and go .6 of a mile to medical facility.
